# **Assets & Reserves**

#### **Added Description Field to Accounts**

By customer request, we have added a new field to Accounts to allow a user to track specific Account Details such as property size and phasing break down. This new field will be included in a new report, also available this publish, that will allow users to easily share these details with boards and other departments.

### New Detail Reports, Assessment & Account Details

By customer request, we have added two new Reserve Reports that allow a user to easily share both Account Details and Assessment Details on a single Account.

### **Simplified Cash Flow Report Excel Formatting**

As part of a larger initiative, we have simplified the Excel formatting of the Cash Flow Report. We have reduced the number of merged cells to allow for easier user utilization. We will continue working through our most popular reports in future publishes.

## **Expiration of Email Tokens**

To limit the number of circulating active Approval emails, we have implemented an expiration for Purchase Orders, RPRs, and OPRs emails. Users will be directed to research Approval details within the desktop application after 60 days of Approval or Denial. Details are indefinitely preserved in Asgard for historical tracking.


