
This publish includes the following updates and enhancements:


Model Statutory Requirements in Scenarios

Statutory Breakout for Reserve Analysis


The Reserve Analysis (Detail & Summary) now has the option to break out Statutory Items. You can opt in or out of this breakout using the report parameter settings.

Add External ID & Description to Asset Import



Account Details, Added ability to easily see Past Expenses


Users can now easily see past expenses in Account Details by removing the default filter. Simply click the black X to see all expenses.
