## Assets & Reserves - Enhanced the Reserve Analysis Reports to Include Deferred Replacements

#### Deferred Replacements Now Included in Reserve Analysis Reports

We've enhanced the Reserve Analysis Report to now include Deferred Replacements components scheduled for replacement during the reporting year will now appear in the results.

This enhancement delivers a forward-looking and comprehensive financial view, enabling better planning for capital expenses associated with recurring replacements.

Please note: If you're running reports for the current year, you may now see Series Expenses that are scheduled for replacement in that same year reflected in the report totals. This is expected behavior and part of our effort to ensure a more accurate reserve planning view.

## Assets & Reserves - Executive Summary Report, Update Remaining & Useful Life Calculation

#### **Weighted Calculations Alignment**

To improve consistency across reports, we've updated the weighted "Useful Life" and "Remaining Life" calculation in the Executive Summary Report. These values will now be based on "Cost If Replaced" rather than "Planned Amount," aligning them with the existing methodology used in the Reserve Analysis Report.

This change ensures more accurate, reliable insights when comparing project timelines and costs across your capital planning tools.


